



3. GRUCom is the telecommunications business unit of Gainesville Regional Utilities lawfully doing business in the State of Florida whose regulated operations are subject to the jurisdiction of this Commission pursuant to Chapter 364, Florida Statutes.
4. GRUCom is a competitive local exchange company (“CLEC”) certified by this Commission that provides transport of high bandwidth communications services on its fiber optic network in Gainesville, Florida and portions of Alachua County, Florida. As such, GRUCom is generally subject to the rules, regulations and orders of this Commission, and such rules, regulations and orders affect GRUCom’s ability to provide local exchange telecommunications service in Florida.
5. GRUCom has an existing interconnection agreement with BellSouth, has equipment collocated at two BellSouth Central Offices in Gainesville and purchases certain unbundled network elements from BellSouth. In this proceeding, BellSouth proposes that the Commission consider certain modifications to BellSouth’s existing interconnection agreements with CLECs in Florida. Pursuant to the Commission’s recent Order Establishing Scope of Proceeding, “existing and pending interconnection agreements between BellSouth and the noticed CLECs will be affected by the outcome of this proceeding.” Order No. PSC-05-0639-PCO-TP, at 4 (Jun. 2005). As a CLEC with an existing interconnection agreement with BellSouth, the substantial interests of GRUCom and its business operations in Florida will be affected by the resolution of the issues in this docket.

WHEREFORE, GRUCom respectfully requests that the Commission permit it to intervene in this proceeding, affording GRUCom full party status, and directing all parties to serve on GRUCom all filings hereafter made in this case.


