

Issue 2: Should the Commission grant BellSouth's Motion to Dismiss?

<u>Recommendation</u>: The Commission should grant in part and deny in part BellSouth's Motion to Dismiss. Staff believes that the Petitioners have standing to bring the subject matter of the Complaint before the Commission, and to seek a refund for all affected customers of any charges collected in violation of the Tariff. However, staff believes that the other relief requested by the Petitioners, i.e. the injunctive relief and attorney's fees, is not within the Commission's jurisdiction. Furthermore, staff believes that BellSouth's alternative request to refer the Complaint to the Division of Regulatory Compliance and Consumer Assistance for consideration pursuant to Rule 25-22.032, Florida Administrative Code (F.A.C.), is inappropriate in this instance.
