


3. The information requested remains in the possession of the Commission Staff.

4. For the reasons set forth above, and in BellSouth's original Requests for Confidential Classification, BellSouth hereby requests that the Commission enter an


Order extending the period of confidential classification for an additional 18 months, or for any longer period of time that the documents remain within the possession of Staff.
