

PETITION TO INTERVENE OF AZUL TEL, INC.

Pursuant to Rules 25-22.039 and 28-106.201(2), Florida Administration Code, Azul Tel, Inc. (“Azul Tel”), through its attorneys, hereby files this Petition to Intervene in the above-referenced docket. In support of this Petition, Azul Tel states as follows:

3. Azul Tel is registered with the Florida Public Service Commission (“Commission”) as an interexchange telecommunications provider (Company Code TJ790). Azul Tel is also certified as a competitive local exchange carrier (“CLEC”)(Company Code TX730).¹ As such, Azul Tel is generally subject to the rules, regulations and orders of the Commission, and such rules,

regulations and orders impact Azul Tel's ability to provide competitive local exchange telecommunications services in Florida.

4. Azul Tel has an Interconnection Agreement with BellSouth Telecommunications, Inc. ("BellSouth") on file with and approved by the Commission. In this proceeding, BellSouth proposes that the Commission consider certain changes to BellSouth's Interconnection Agreements with CLECs in Florida. Accordingly, decision which the Commission makes in this proceeding will affect Azul Tel's interests.

5. Azul Tel first learned of the existence of this generic docket when it received notification from BellSouth on June 21, 2005, that "[i]t is BellSouth's position that all TRO and TRRO issues must be addressed in [this] docket." Although it has recently engaged in negotiations with BellSouth regarding proposed amendments to its Interconnection Agreement, Azul Tel seeks to intervene in this docket to protect its interests and obtain reasonable assurances that any future negotiations are engaged in within the context of this generic proceeding. By petitioning to intervene in this docket, Azul Tel does not waive its statutory and contractual right to negotiate revisions to its interconnection agreement with BellSouth.
