In addition, please provide a list of any utility assets that were not transferred to the City or a statement indicating that all utility assets were transferred; a statement describing the disposition of customer deposits and interest thereon; and a statement regarding the disposition of any outstanding regulatory assessment fees, fines or refunds owed. Finally, please provide the date the City of Avon Park Utilities proposed to take official action to acquire the utility as required by Rule 25-30.037(4)(f), Florida Administrative Code.
