INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION**

BellSouth Telecommunications, Inc. ("BellSouth"), and pursuant to Rule 25-22.006, Florida Administrative Code, files its Notice of Intent to Request Specified Confidential Classification and states the following:

1. On June 3, 2005, the Florida Public Service Commission (hereinafter "Commission"), requested that BellSouth provide certain information to help the Commission evaluate the status of competition in the telecommunications industry. This information is being provided in connection with the Commission's request.

2. BellSouth's response to Tables 1 and 2 include confidential business information that is considered proprietary to BellSouth. BellSouth has produced on CD-ROM documents that contain confidential business information that is considered proprietary.
