



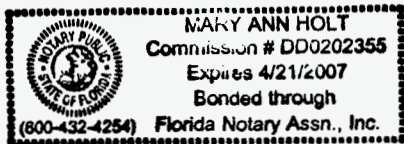

CUSTOMER NOTICE

By Proposed Agency Action Order No. PSC-05-0624-PAA-WS (PAA Order), issued June 7, 2005, the Florida Public Service Commission proposed final water and wastewater rates for Indiantown Company, Inc. The PAA Order was not protested, and the rates approved by that PAA Order were finalized by Order No. PSC-05-0708-CO-WS, issued June 29, 2005. The utility has requested that its tariff containing the final Commission approved rates be made effective on July 20, 2005. Meters will be read on August 18 – 19, 2005, and customers will be billed at the new rates for service received subsequent to the July meter reading. The first bills computed at the new rates will be sent to customers on or about September 1, 2005.

The rates prior to filing, the Commission's approved interim rates, the utility's proposed final rates, and the Commission's approved final rates, on a monthly basis are set forth below:
