XO Communications Services, Inc. (XO) generally supports the response of the Competitive Carriers of the Southeast (CompSouth) to BellSouth's Motion for Summary Final Order or Declaratory Ruling and Cross-Motion for Summary Final Order or Declaratory Ruling filed today.

XO does not object to the withdrawal of the issues delineated in CompSouth's response; however, the Commission should be aware that numerous *TRRO* issues, including Issue 6, are the subject of a motion for reconsideration filed by a number of CLECs, including XO, in *the Matter of Unbundled Access to Network Elements/Review of Section 251 Unbundling Obligations of Incumbent Local Exchange Carriers*, WC Docket No. 04-313/CC Docket No. 01-338 (the "TRRO Docket"). There is also a pending forbearance petition in the docket at the FCC, with comments due September 12.

While XO does not object to the withdrawal of the issues under the current status of the law, it does reserve any and all rights to bring these issues, and any other issues, back before this Commission, in this or a separate docket, should any FCC ruling result in further change of law.
