Dear Sue:

Please find attached a two (2) public versions and one (1) sealed confidential version of RNK Telecom, Inc.'s ("RNK") 2005 CLEC Local Competition Report Data Request responses. As requested in the Commission notice, RNK has also included a disk containing electronic copies of the *Public* and *Confidential* versions of the responses.

RNK contemporaneously files a Request for Protective Order, as provided in Rule 25-22-006(5)(a) of the Commission's rules, requesting confidential treatment of the information contained in a sealed manila envelope labeled "Confidential". This version contains sensitive information, which RNK considers proprietary and confidential. Disclosure of the confidential information could adversely effect RNK's business affairs and give competitors an unfair advantage. RNK respectfully requests that the identified responses be viewed by Commission staff only in the discharging of its duties, and not be released to the public, consistent with RNK's request, if granted.

#### CLAIM OF CONFIDENTIAL TREATMENT

RNK Telecom, Inc. ("Respondent"), pursuant to Rule 25-22.006(5)(a) of the Florida

Administrative Code hereby requests confidential treatment for certain responses 5(a) and

5(f) to the 2005 Competitive Local Exchange Carrier Data Request from the Florida

Public Service Commission. This request pertains to confidential customer location,

marketing plans and product deployment estimates (hereinafter, "Proprietary

Documents") submitted with Respondent's 2005 Competitive Local Exchange Carrier

Data Request. In support of its request, Respondent states as follows:

## **JUSTIFICATION**

The material contained within the Proprietary Documents comprise highly confidential customer location data and product deployment schedules, information that would be of significant benefit to competitors. By reviewing customer locations<sup>1</sup>, competitors could determine the extent of Respondent's operations, which could cause significant and possibly irreparable harm to Respondent. Further, Respondent's information regarding marketing plans and deployment schedules will give competitors the ability to realize potential markets and thereby unfairly usurp Respondent's research and work. The

information contained within the Proprietary Documents is of no benefit to the general public. Release of the information contained within the Proprietary Documents to competitors or potential competitors could cause **irreparable** harm to the Respondent. The protection sought herein is consistent with relief granted to other Respondent's under similar circumstances in past proceedings.

# **CONCLUSION**

WHEREFORE, Respondent respectfully submits that there is substantial basis for restricting public disclosure of its financial statements, and therefore, requests that the Proprietary Documents be withheld from public inspection.
