I apologize for the misunderstanding. I will send you the 2004 Regulatory Assessment Fee (RAF) returns for both the IXC and CLEC certificates via separate e-mails.

If you wish to cancel the IXC Registration in Docket No. 040935-TI, please replace the following paragraph in your settlement letter:

"Enclosed are the company's 2003 and 2004 Regulatory Assessment Fee returns, along with full payment for the fees, including late payment charges for the years 2002 and 2003. To resolve this docket, the company respectfully requests that the Commission accept its proposal to voluntarily cancel its registration in lieu of the \$500 fine imposed."

Since there is not currently a docket pending against the company's CLEC Certificate (TX545), the company just needs to pay the outstanding late fees of \$7.09 for late payment of the 2002 fee plus the 2004 Regulatory Assessment Fee.
