SECOND JOINT MOTION TO MODIFY ORDER ESTABLISHING PROCEDURE

On behalf of BellSouth Telecommunications, Inc. ("BellSouth"), and Florida Digital Networks Inc., d/b/a FDN Communications ("FDN"), BellSouth files this Second Joint Motion to Modify Order Establishing Procedure and says:

- 1. On April 20, 2005, the Commission issued the Order Establishing Procedure¹, which set forth, among other things, the controlling dates for the filing of testimony by the parties regarding the issues in Phase I of this proceeding. (Order Establishing Procedure, at 7)
- 2. That schedule was amended at the request of BellSouth, FDN and Supra with a new direct testimony being set for August 2, 2005.
- 3. Over the last week, the Parties have been, and continue to be, engaged in settlement negotiations that encompass nearly all of the pending issues in this proceeding. To date, the Parties have reached agreement on eight (8) of the issues in this proceeding.
- 4. More importantly, recent settlement discussions have reached a point where there is a good likelihood that all the issues in this proceeding (including the rates) could be resolved through mutual assent of the Parties.

- 5. The Parties believe that a short extension to the current procedural schedule will allow the Parties time to conclude these settlement discussions and propose a Stipulation to the Commission for consideration.
- 6. The Parties propose that the entirety of the current schedule in the Order Establishing Procedure be extended for sixteen (16) days and that the hearing be re-scheduled for the end of October 2005.
- 7. MCI has no objection to the relief requested. The remaining CLECs have been advised of this Motion, but have not yet indicated whether they have any objection to the relief sought.
- 8. No Party will be prejudiced by the granting of this Motion.

WHEREFORE, BellSouth, on behalf of BellSouth and FDN, respectfully requests that the Order Establishing Procedure be modified as set forth above.
