On July 12, 2004, Saturn Telecom Services Inc. d/b/a STS Telecom (STS) filed its Complaint against BellSouth Telecommunications, Inc. (BellSouth), seeking resolution of monetary dispute regarding alleged overbilling under interconnection agreement, and requesting stay to prohibit any discontinuance of service pending resolution of matter.

Following a significant exchange of pleadings, on June 29, 2005, Order No. PSC-05-0702-FOF-TP was issued, granting BellSouth's Motion for Summary Final Order, and closing the Docket. However, on July 14, 2005, STS electronically filed a Motion for Reconsideration and Motion for Stay. (Those identical motions were refiled as hard copies on July 18, 2005).

On July 27, 2005, STS submitted a letter advising that it had reached a satisfactory agreement with BellSouth and did not wish further action on this Docket. STS specifically requested in its letter that this Docket be closed. Accordingly, based on the STS letter of July 27, 2005, the Motions are withdrawn and Order No. PSC-05-0702-FOF-TP should stand as the controlling Order in this Docket. Therefore, this Docket should be (reclosed.)
