On May 23, 2005 Paradise Lakes Utility, L.L.C. submitted its Application to the Florida Public Service Commission for revision to Wastewater Tariff Sheet No. 16.0 and Water Tariff Sheet Nos. 18.0 and 19.0. These changes were submitted in order to revise miscellaneous service charges and meter installation fees imposed by the Utility.

By Order No. PSC-05-0775-TRF-WS issued on July 26, 2005, the Florida Public Service Commission approved the Utility's Application for these changes in charges. That Order has now become final. The charges approved are designed to allow the Utility the opportunity to recover its increased costs for providing these services.
