NOTICE OF HEARING ON CONFIRMATION OF PLAN AND RELATED DEADLINES

The debtor in possession, BroadBand Office, Inc. (the "Debtor"), and the Official Committee of Unsecured Creditors (the "Committee") (collectively, the "Plan Proponents") have filed the First Amended Joint Liquidating Plan of the Debtor and the Official Committee of Unsecured Creditors (Docket No. 1072) (as amended from time to time, the "Plan") and are now seeking confirmation of the Plan.
