

**Sprint-Florida, Incorporated's REVISED Request for Confidential Classification
Pursuant to Section 364.183(1), Florida Statutes**

Sprint-Florida, Incorporated (hereinafter, "Sprint") hereby request that the Florida Public Service Commission ("Commission") classify certain documents and/or records identified herein as confidential, exempt from public disclosure under Chapter 119, Florida Statutes and issue any appropriate protective order reflecting such a decision.

1. The information that is the subject of this request is confidential and proprietary as set forth in paragraph 3. Sprint previously filed a Claim of Confidentiality related to this information and is filing this request pursuant to Rule 25-22.006, F.A.C. The following documents or excerpts from documents are the subject of this request:

**Sprint's 4th Supplemental Response to KMC's 1st Interrogatories No. 15
(attachment on CD only) Document No. 05193-05 (entire CD)**

**Highlighted information contained in pages 2 & 3 of Sprint's Supplemental
Response to KMC's 2nd Interrogatories. Document No. 05998-05**

2. Two redacted copies of the information are attached to this request. Unredacted copies of the information were filed under separate cover on May 27, 2005 (Document No. 05193-05) and June 23, 2005 (Document No. 05998-05).

3. Document No. 05193-05 was inadvertently omitted from Sprint's previously filed Request for Confidential Classification filed on August 2, 2005. Although this Request is

outside the 21 day time-frame set forth in Rule 25-22.006, F.A.C, Sprint believes that the request should nevertheless be granted, since the information for which confidentiality is requested is customer account information related to KMC. KMC's competitively sensitive confidential proprietary business information should not be compromised by Sprint's inadvertent oversight.

4. The information for which the Request is submitted contains KMC or other CLEC customer account information that Sprint is required by law (s. 364.24, F.S.) and/or contract (Sprint's interconnection agreements) to keep confidential.


5. Section 364.183(3), F.S., provides:

- (3) The term "proprietary confidential business information" means information, regardless of form or characteristics, which is owned or controlled by the person or company, is intended to be and is treated by the person or company as private in that the disclosure of the information would cause harm to the ratepayers or the person's or company's business operations, and has not been disclosed unless disclosed pursuant to a statutory provision, an order of a court or administrative body, or private agreement that provides that the information will not be released to the public. The term includes, but is not limited to:
 - (a) Trade Secrets.
 - (b) Internal auditing controls and reports of internal auditors.
 - (c) Security measures, systems, or procedures.
 - (d) Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the company or its affiliates to contract for goods or services on favorable terms.
 - (e) Information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of information.
 - (f) Employee personnel information unrelated to compensation, duties, qualifications, or responsibilities.

6. Section 364.24, Florida Statutes, prohibits a telecommunications company from intentionally disclosing customer account records, except as authorized by the customer or allowed by law.
7. The subject information has not been publicly released by Sprint.

Based on the forgoing, Sprint respectfully requests that the Commission grant the Request for Confidential Classification, exempt the information from disclosure under Chapter 119, Florida Statutes and issue any appropriate protective order, protecting the information from disclosure while it is maintained at the Commission.

Supplemental Response: In its Interrogatory KMC requested information related to LEC's terminating traffic in the Tallahassee and Ft. Myers service areas only. Sprint's Response identified the only LEC against which Sprint has made a claim in those specified service areas. However, in the interests of complying with the Commission's Order No. PSC-05-0650-PCO-TP, involving LECs against which Sprint has made claims who terminate traffic to Sprint in Florida, but not in Sprint's Tallahassee or Ft. Myers service areas.

Sprint has e-mails and other documents relating to the claims made against another CLEC, identified in response to Interrogatory No. 36. However, these documents contain highly confidential, competitively sensitive information regarding this CLEC which Sprint is required by law and its interconnection agreement with the CLEC to protect, including providing notice to the CLEC when Sprint has received a lawful request to produce otherwise confidential information. Sprint recognizes that KMC and Sprint have entered into a protective agreement to govern confidential information provided in discovery in this proceeding. In order to comply with KMC's discovery request, while still protecting the confidentiality of Sprint's customer information to the greatest extent possible, Sprint will make the documents that are responsive to this request available for viewing by counsel for KMC at Sprint's offices at a mutually agreeable time, upon notice to the CLEC that Sprint intends to allow KMC access to this information.
