**FIFTEENTH NOTICE OF INTENT TO REQUEST
CONFIDENTIAL CLASSIFICATION**

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Fifteenth Notice of Intent to Request Confidential Classification of confidential portions of PEF's supplemental responses to OPC's First Request for Production (Nos. 1-75), as Staff has requested copies of PEF's responses to this discovery. Specifically, as stated in PEF's Third Request for Confidential Classification, filed June 17, 2005, portions of the supplemental documents responsive to Request 5 contain information related to changes made to PEF's internal policy and assessment of various charging practices, along with other sensitive business information that PEF does not make publicly available.

Disclosure of such information would adversely affect PEF's competitive business interests.


