Surrender of IXC Registration

Dear Ms. Bayó:

Teleglobe America Inc. ("TAI"), hereby surrenders its Registration to provide interexchange services within Florida issued by the Florida Public Service Commission (the "Registration"). TAI does not provide any telecommunications services in Florida pursuant to its Registration. Accordingly, no customers will be affected by the cancellation of TAI's Registration.

TAI is a Delaware corporation whose principal offices are located at One Discovery Square, 4th Floor, 12010 Sunset Hills Road, Reston, VA 20190. TAI is an indirectly wholly-owned subsidiary of Teleglobe International Holdings Ltd, a Bermuda company ("TIHL"), and is a party to a stock purchase agreement whereby it will be acquired by Videsh Sanchar Nigam Limited ("VSNL"), a large international telecommunications company headquartered in India. TAI was authorized by the Commission in Docket No. 03-0922-TI to provide interexchange telecommunications services in Florida but does not currently provide any services pursuant to the authorization (IXC Registration Code TJ837) and has no current plan to provide any such services. TAI's primary business is to provide wholesale international services to other carriers for their country-to-country international traffic, and that focus is expected to continue after the VSNL transaction closes. TAI recognizes that should its business plans change in the future, it would need to re-apply for the requisite authorization(s).

Because no customers will be affected by the cancellation of TAI's Registration, there will be no need for any customer notifications and there will be no possibility of any service disruptions. Accordingly, TAI requests that the cancellation become effective immediately or as soon as the Commission can take any necessary administrative action.
