Issues in Response to Memorandum Dated August 18, 2005

Dear Ms. Bayó:

In response to the Memorandum in this docket dated August 18, 2005, inviting all interested persons to submit a preliminary list of issues, we would like to submit a preliminary list of issues on behalf of Greater Orlando Airport Authority (GOAA). By a separate petition, GOAA has sought to participate in the case as a party.

The preliminary list of issues is as follows:

- (1) The intent and scope of the Airport Exemption and the STS Order in exempting shared airport arrangements from the regulations applicable to commercial STS operators, including but not limited to the application of the Exemption and STS Order to the provision of shared airport services to concessions located in the airport terminal building, such as restaurants and retail shops.
- (2) The need for continued control and operation of airport telecommunications systems by the local government authorities that are responsible for airport operation, for the security, safety and convenience of the traveling public, and for the efficient integration of such support services with other airport functions.
- (3) The effect of changing the current practice by denying the Airport Exemption, to subject a local government's airport telecommunications systems to regulation as an STS provider.
