

NOTICE OF FILING TESTIMONY AND EXHIBITS OF

PURSUANT TO ORDER NO. PSC-05-0748-FOF-EI

Progress Energy Florida, Inc. ("PEF" or the "Company"), files the testimony and exhibits of Javier Portuondo in accordance with the Order of the Florida Public Service Commission ("FPSC" or the "Commission") in Docket No. 041272-EI resolving PEF's Petition for approval of storm cost recovery clause for recovery of extraordinary expenditures related to Hurricanes Charley, Frances, Jeanne and Ivan. Specifically, the Commission's Order No. PSC-05-0748-FOF-EI required the Company to file revised storm cost surcharge factors for the period January through December 2006 incorporating a true-up of estimated costs and sales to actual costs and sales and further held open Docket No. 041272-EI to address the true-up of the actual storm restoration costs until the Commission Staff has verified that the true-up of the Company's 2004 storm costs is complete. PEF accordingly files the testimony and exhibits of Javier Portuondo demonstrating the revised surcharge factors for the period January through December 2006 incorporating the true-up of the estimate to actual 2004 storm costs to enable the Commission Staff to verify the true-up of the Company's 2004 storm costs is complete.
