**JOINT MOTION OF METROPCS CALIFORNIA/FLORIDA, INC. AND BELLSOUTH
TELECOMMUNICATIONS, INC. FOR EXTENSION OF TIME TO FILE TESTIMONY**

MetroPCS California/Florida, Inc. ("MetroPCS") and BellSouth Telecommunications, Inc. ("BellSouth") (collectively, the "Parties"), by their undersigned attorneys, hereby move the Florida Public Service Commission ("Commission") for an extension of time to file Direct Testimony in this proceeding to arbitrate certain unresolved issues arising from the Parties' interconnection negotiations. In support of this Motion, the Parties show as follows:

1. Pursuant to the Order Establishing Procedure issued on August 24, 2005 by

2. The Parties believe they have reached a settlement in principle of the issues raised in MetroPCS' petition for arbitration, but they require additional time to finalize the documentation of that settlement and the resulting interconnection agreement.

3. The Parties request a two week extension of time to file their Direct Testimony and Exhibits in order to permit them to finalize their settlement and interconnection agreement. In the event that the Parties are unable to do so, the remainder of the schedule adopted in Order No.

PSC-05-0861-PCO-TP should remain intact.


