Central Sumter Utility Company, L.L.C. responds as follows to the request of the Commission dated August 31, 2005:

1. The Utility sent the warranty deed for the treatment plant site for recording in Sumter County. The recording process in that county usually takes about 30 days. The Utility has not received the recorded deed from the County Clerk; however, it expects to receive it within the next 10 days. The Utility will forward a copy of the recorded deed to the Commission at that time.

2. The Utility will file for its initial rates and charges at least nine months prior to the anticipated need for service. At this time, the exact date when service will be required is unknown. However, the Utility expects to begin providing service sometime in 2009.
