RE: Recommendation to the Office of the General Counsel - Docket No. 050600-TL

On September 2, 2005, Sprint-Florida, Incorporated, d/b/a Sprint, submitted an application to NeuStar, the Number Pooling Administrator (PA), for additional numbering resources in the Belleview (BLVWFLXADS0) rate center, specifically one (1) 1,000 block to meet a customer's request for 20 consecutive numbers in order to utilize Direct Inward Dialing, (DID). Also on September 2, 2005, the PA denied the Sprint application because it did not meet the utilization criteria required for a new block of numbers.

On September 9, 2005, Sprint filed a petition requesting that the Commission overturn the PA's decision to deny numbering resources for the Belleview (BLVWFLXADS0) rate center. In accordance with Commission Order PSC-02-0352-PAA-TL, (Docket No. 020087-TL) which approved an expedited process for the PA code denials, we have examined the Sprint petition and have determined the following:

- 1) The carrier has demonstrated that it has a customer in need of numbering resources;
2) The carrier has shown that it is unable to provide services to this potential customer because of NeuStar's denial of the numbering resources; and
3) The customer will not be able to obtain service from the provider of his/her choice because the carrier does not have the numbers available.

Since the three criteria of PSC-02-0352-PAA-TL have been met, please prepare an administrative Proposed Agency Action Order to be issued within seven business days of this memorandum (September 28, 2005), as outlined in the expedited code denial process orders. The PA should be directed to provide Sprint the needed numbering resources to meet its customer's needs in the Belleview (BLVWFLXADS0) rate center.
