
AMENDMENT TO SECTION 63.71 APPLICATION

(collectively, "CoreComm"), through their undersigned counsel, hereby file this Amendment to the above-referenced Application filed on September 9, 2005. Specifically, after scrubbing its customer lists, CoreComm determined that it did not have any customers in Georgia, Kentucky, Maryland, New Jersey, and Washington. As such, CoreComm will not be discontinuing service to customers in those states. CoreComm, therefore, requests that CoreComm Maryland, Inc. and CoreComm New Jersey, Inc. be removed as parties to this proceeding since these companies do not have any customers affected by the discontinuance. In addition, CoreComm amends its application to reflect that the total number of customers affected by the discontinuance is fourteen (14), which includes two (2) customers in Florida, one (1) customer in Minnesota, nine (9) customers in Pennsylvania, one (1) customer in Rhode Island and one (1) customer in Virginia.

CoreComm respectfully requests that the Commission approve the Application as amended by this filing.
