Re: Request for State Waiver to Obtain Full Code

SBC Long Distance, LLC d/b/a SBC Long Distance, respectfully submits this request for approval of a State Waiver to obtain seven full code's from NeuStar, Inc., numbering resources, with the sixth digit ending in something other than 0, 1, and 9, which are not compatible with our customer's PBX system. SBC Long Distance has insufficient number resources in the following rate centers to meet the request of our customer. **Boynton Beach, Clearwater, Miami, North Dade, Orlando, Sanford, and West Palm Beach** in Florida.

On September 22, 2005, SBC Long Distance submitted a Part 1A and a Months to Exhaust (MTE) and Utilization Certification Worksheet – TN Level in the Pooling Administration System (PAS); copies of the Part 1A and MTE worksheet have been attached to this request. Request's for full codes were requested for the Boynton Beach, Clearwater, Miami, North Dade, Orlando, Sanford, and the West Palm Beach rate centers. At the completion of the code request, PAS generated an error message indicating that the required utilization level was not met. SBC Long Distance currently has blocks assigned out of the rate centers, but they do not meet the customer requirement of the sixth digit ending in something other than 0, 1 or 9. Appropriately, the State Waiver Option was selected in PAS.

The code's that are desired for assignment are available as of September 28, 2005 according to the NANPA Central Office Code Availability Report.
