Thank you for your correspondence regarding the application filed in the above-referenced docket. In your letter, you indicate that you object to Gistro, Inc.'s application.

Please be advised that Gistro, Inc. has applied for a certificate to continue to operate and to begin charging rates for wastewater collection service only. The application does not contemplate a change to your current wastewater collection provider. Bonita Springs Utilities will continue to provide your wastewater treatment service.
