

Tast year, Jerald Rebensdorf, president of the Fresno Cooperative Raisin Growers, had 110 people picking his 600 acres. This year, he's making do with 51.

Raisins' remain one of the nation's most labor-intensive harvests. About 40,000 workers are needed to hand-pick the grapes over six weeks, then dry them in the sun

This year, growers expect to harvest at least 240,000 tons of raisins. It takes about five pounds of grapes to make one pound of raisins—and all that fruit has to be off the vines before Sept. 20, or crop insurers won't cover any losses caused by rain.

In a year like this one, in which cool rains lasted well into the spring, farmers are tying to squeeze the usually tight harvest into even fewer weeks.

But raisin farmers aren't the only ones scrambling for workers. Farmers growing a majority of the nation's vegetables and fruits need a reliable supply of laborers willing to work for the prevailing wage of \$7 to \$8 per hour to stay competitive in the global market.

For the last couple of years, growers said they've felt the labor pool tightening as workets leave low-wage, seasonal jobs for better-paying, year-round city jobs.

Construction jobs, starting at \$10 an hour, are a big draw, especially in fast-growing inland areas such as the Central Valley, the state's farm bell, experts said.

Meanwhile, a beefed-up border patrol has led to more arrests along the Mexican border, making it harder for illegal immigrants to reach jobs
