**ORDER AND NOTICE OF RESCHEDULED HEARING  
AND ORDER EXTENDING AUTOMATIC STAY IN SECTION "A"** COMMISSION  
CLERK

As a result of circumstances arising out of Hurricane Katrina, the Court having *sua sponte* considered the continuation of matters noticed for hearing on September 20, 2005 and the issue of termination of the automatic stay provided by 11 U.S.C. §362(a) when preliminary and final hearings of requests for relief from the stay are not held within certain time periods as contemplated by 11 U.S.C. §§362(d) and (e);

The Court having considered these issues and determined that compelling circumstances exist because of the damage and disruption caused by Hurricane Katrina that prevented the timely noticing and hearing of requests for relief from the stay provided by 11 U.S.C. §362(a) and having further determined that in the interest of justice the automatic stay provided by 11 U.S.C. §362(a), should be extended or re-imposed;

**IT IS ORDERED**, that:

1. Hearings on all matters, except Motions for Relief from the Automatic Stay, scheduled for September 20, 2005 between the hours of 8:00 a.m. and 12:00 p.m. are rescheduled for hearing on November 15, 2005 at the United States Bankruptcy Courthouse, 707 Florida St., Baton Rouge, Louisiana. 70801, Courtroom 107, at a time identical to that originally noticed. All Motions for Relief from the Automatic Stay scheduled for September 20, 2005 are hereby rescheduled for 2:00 p.m. on November 15, 2005 at the United States Bankruptcy Courthouse, 707 Florida St., Baton Rouge, Louisiana. 70801, Courtroom 107;

2. In all cases in which Motions for Relief From the Automatic Stay were requested, the stay shall remain in effect through the conclusion of the continued hearing due to compelling circumstances. In the event that the automatic stay was automatically lifted pursuant to the provisions of 11 U.S.C. §362(e), the stay is hereby re-imposed and shall remain in effect through the conclusion of the continued hearing.
