



JOINT MOTION FOR EXTENSION OF TIME

BellSouth Telecommunications, Inc. ("BellSouth") and MCImetro Access Transmission Services LLC ("MCI"), pursuant to Rule 28-106.204(5), Florida Administrative Code, requests that the Florida Public Service Commission ("Commission") grant the parties a seven (7) day extension of time or until October 21, 2005, in which to file their Direct Testimony. In support of this motion, BellSouth states the following:

1. Pursuant to the Order Establishing Procedure, issued on September 19, 2005, Order No. PSC-05-0927-PCO-TP, Direct Testimony is due on October 14, 2005.
2. BellSouth and MCI jointly request an additional week or seven (7) days to file their Direct Testimony in the captioned docket.
3. Neither the parties nor Staff would be prejudiced by a seven (7) day extension of time as the Rebuttal deadline is December 1, 2005.

WHEREFORE, for the foregoing reasons, BellSouth and MCI respectfully request that the Commission grant the parties a seven (7) day extension of time or until October 21, 2005, in which to file their Direct Testimony.
