**BELLSOUTH LONG DISTANCE, INC.'S  
REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION**

BellSouth Long Distance, Inc. ("BSLD"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, hereby files its Request for Specified Confidential Classification.

1. On October 31, 2005, BSLD filed flow-through tariff revisions in conjunction with Docket No. 030961-T1, Order No. PSC-03-1469-FOF-TL and Florida Statute §364.163(2) with the Division of Competitive Markets and Enforcements. Information provided in BSLD's associated worksheet is considered proprietary, confidential business information and should not be disclosed.

2. Pursuant to Rule 25-22.06(3)(a), BSLD hereby files this Request for Specified Confidential Classification because the information contained in BSLD's worksheet includes confidential business information utilized by BSLD to conduct business. A more specific description of this information is contained in Attachment A. Public disclosure of this information would cause competitive harm to BSLD and provide competitors with an unfair advantage. The information discussed in the Request for Specified Confidential Classification is valuable and BSLD strives to keep it secret. Therefore, such information should be classified as confidential business information.

3. Attachment A to BSLD's Request for Confidential Classification contains an explanation of the proprietary information along with a list that identifies the location of the information designated by BSLD as confidential.

4. Attachment B to BSLD's Request for Confidential Classification is redacted copies of the document containing the confidential information.

5. Attachment C to BSLD's Request for Confidential Classification is a highlighted copy of the document containing the confidential information.


6. The information discussed in this Request for Specified Confidential Classification is valuable, BSLD treats this information as confidential in all requests, and this information has not been generally disclosed.

**Explanation of Proprietary Information**

1. This information contains a breakdown of the estimated minutes of switched access traffic, broken down by specific originating or terminating local exchange company, used by the Company. This traffic pattern information is proprietary to BellSouth Long Distance and disclosure would impair the competitive business and cause harm to BellSouth Long Distance. Consequently, this information should be classified as proprietary, confidential business information pursuant to Section 364.183(3)(e). Florida Statutes and is exempt from the Open Records Act.
2. This information contains a breakdown of the intrastate switched access savings the Company is expected to realize, by local exchange company rate element and by BellSouth Long Distance line of business. This information could be used to derive the Company's traffic patterns and other competitive information. Traffic pattern information is proprietary to BellSouth Long Distance and disclosure would impair the competitive business and cause harm to BellSouth Long Distance. Consequently, this information should be classified as proprietary, confidential business information pursuant to Section 364.183(3)(e). Florida Statutes and is exempt from the Open Records Act.
3. This information reflects the total dollar amounts of BellSouth Long Distance's intrastate switched access charge reductions. This information is proprietary to the Company as it shows a breakdown by segment of the Company's lines of business and disclosure would impair the competitive business and cause harm to BellSouth Long Distance. Consequently, this information should be classified as proprietary, confidential business information pursuant to Section 364.183(3)(e). Florida Statutes and is exempt from the Open Records Act.

5. This information contains the estimated results of BellSouth Long Distance's intrastate switched access charge reduction flow-through. This information could be used to derive the subscription and usage levels for various BellSouth Long Distance calling plans and disclosure would impair the competitive business and cause harm to BellSouth Long Distance. Consequently, this information should be classified as proprietary, confidential business information pursuant to Section 364.183(3)(e), Florida Statutes and is exempt from the Open Records Act.
