Dear Ms. Blanca:

A customer has applied for service requesting two 1.5" meters and a 6" fire line. Our tariff does not have a rate for service for those sizes.

We calculated a fair, just and equitable rate for these new classes applying the accepted AWWA equivalents. The 1.5" meter is based on 5 times the 5/8" x 3/4" size and we have drafted the amended tariff Sheet No. 12.0 attached. The 6" fire line is based on one twelfth of 70 times the 5/8" x 3/4" size and we have drafted the amended tariff Sheet No. 12.1 attached.

The customer was hooked up on October 31, 2005 and we expect the revenues from this customer to be about \$250 per month. The developer has estimated that there may be 3 or 4 more customers over the next few years that may request this rate.
