Greetings,

This is a letter of objection to the intent of MSM Utilities, LLC to amend its Water Certificate No.611-W and Wastewater Certificate No.527-S to add territory in Charlotte County, Florida.

We can see no need what so ever for added water service in any of the proposed territory to be added. All of the existing homes in that territory now have good artesian wells in place.

With the possible exception of a few lots on the north side of Tamayo Dr. and Snook circle there is no need for utility wastewater service. After hurricane Charlie devastated most of Peace River Subdivision, Charlotte County has inspected and approved many, many of the septic systems and found no need for utility service.

We can see no public need for this or how any public good can come of it.

This seems to be an attempt by Maltese Developments, Inc and MSM Utilities LLC to add more revenue base to their project.

We do not think that any thing of this magnitude and expense to us should be done without a request from us or having a need for this proven by science and engineering conclusions. This should even then only be done after public hearings with the effected property owners during the winter months when most of these owners would be able to have some input in the process.

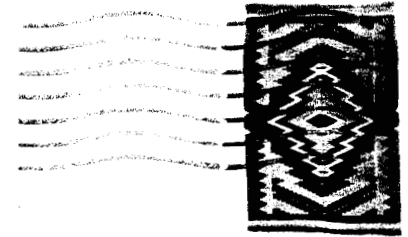
