Please be advised that I act on behalf of Mrs. Doreen McArthur. This is our formal notice of objection to the application of MSM Utilities. Our objections are as follows:

1. The abutting area to the subject lands was severely destroyed in 2004 by the effects of Hurricane Charlie, with significant increased expenses being felt by the residents. There is a significant concern that any additional expenses which the residents would have to face as a result of this application would be crushing and in most cases an expense which the residents cannot make.

2. Following Hurricane Charlie, all well and septic systems of the abutting areas were inspected. Necessary improvements were made to bring the wells and septic up to current standards. This in and of itself caused significant financial hardship to the residents.
3. The private roads to be utilized in this development would be severely damaged. Again, with undue financial hardship flowing through to the residents.
4. There is insufficient evidence in the application itself. The residents would be concerned that the absence of any information with respect to the development could lead residents with the wrong impression as to what the purpose of the development and the extent of development will ultimately be.
