
Re: Proposed Sewer Connection for Water

LEGAL NOTICE

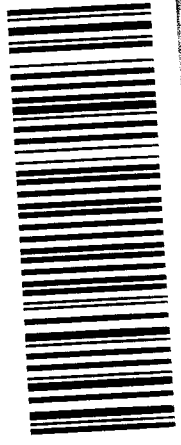

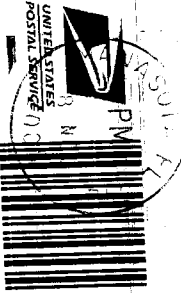
