Dear Mr. deMenzes:

Pursuant to Order No. PSC-04-0356-PAA-WU, issued April 5, 2004, in the above docket, the Commission approved \$96,718 for a distribution system project to replace old laterals and potable water lines, per county code, and replace all regular meters with automated meter read type meters. Of the \$96,718, developers were to contribute \$19,910. Instead of refunding overearnings, the Commission ordered RWS to use those revenues to fund the pro forma projects of approximately \$76,808 (\$96,718 - \$19,910) and to book those revenues to CIAC. The utility was required to complete the pro forma additions by December 31, 2005.
