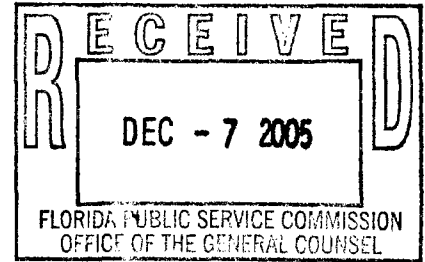

Dear Mr. Keating:

Pursuant to the Commission's action at its November 29, 2005 Agenda Conference, please accept this letter as notification that Florida Power & Light (FPL) has waived the connection fee for all identified Hurricane Katrina victims establishing new accounts in FPL service territory. Based on the provision of FPL's Tariff 4.020 as approved in Order No. 04-0985 issued 10/11/04 in Docket No. 040914-EI, FPL established a process to identify current customers who indicate they are relocating due to a hurricane. In 2005, FPL applied this process to new customers identifying themselves as victims of Hurricane Katrina and waived the service connection fee.

I believe this satisfies the Commissioners' decision to make the connect fee waiver available to new customers displaced by Hurricane Katrina prior to the tariff modification approval date of November 29, 2005.
