Dear Ms. Bayo:

The Commission Staff has requested that Peoples Gas System ("Peoples") consent to an extension of the 60-day requirement for Commission action (under the file-and-suspend statute) on the Company's tariff filing in the above docket in connection with the Staff's need and desire to have the filing considered by the Commission at its February 21, 2006 agenda conference, rather than at an agenda conference within the 60-day period required by the statute.

Peoples has previously agreed to an extension of the 60-day requirement until February 21, 2006, but has now been advised of the cancellation of the February 21 agenda conference. Under the circumstances, Peoples agrees to a further extension, to and including February 28, 2006, of the 60-day requirement under the file-and-suspend statute for Commission action on the Company's tariff filing in the above docket.
