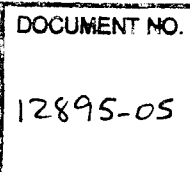

**TALLAHASSEE** — The following items are among those scheduled for consideration by the Commission at the September 20, 2005, Agenda Conference.
