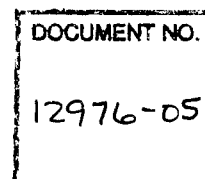

This docket was protested by Verizon and staff is to address the protest in a recommendation.

The reason for this e-mail is to notify everyone that we have received a new filing today wherein Claricom, a registered IXC and certificated CLEC will be merged with Matrix (currently a registered IXC, with pending CLEC authority - based upon the outcome of the protested Docket 050200-TX in which Matrix seeks CLEC authority).

Today's filing requests cancellation of Claricom's IXC and CLEC and merger with Matrix's IXC and CLEC (pending). Thus, the only way this can all happen is for Matrix to have CLEC authority. The request for cancellation of Claricom's IXC/CLEC and the request for merger approval of Claricom's business into Matrix will be docketed today.

What I am attempting to say is that the new filing requires that 050200-TX be resolved as soon as possible. The outcome of 050200-TX will, in essence, drive the outcome of the new docket. The target for the cancellations/merger is December 31, 2005.

It seems reasonable that we must take a position on 050200-TX and file a recommendation on 10/6/05. And then follow-up with another filing on the new matter, exactly when I am not sure. The PAA protest periods after a vote by the Commission makes the time line awkward at best.

It may require we contact the filer of the new request and ask them to revise their dates. However, that should not be necessary if we file a rec no later than 10/6 in Docket 050200-TX. We were hoping to file this earlier, but due to unforeseen circumstances, that has not happened.
