

Pursuant to Commission Rule 25-30.550, Florida Administrative Code, enclosed is a copy of a Water and Wastewater Utility Agreement entered into between Lake Utility Services, Inc. ("Lusi"), and John Kingman Keating, as Trustee, for water and wastewater service to the Sawgrass Bay Subdivision in Lake County, Florida. LUSI's facilities currently have a total permitted capacity of 10,790 ERCs for water and 1,785 for wastewater. The connected load for the current treatment plants is approximately 8,270 ERCs for water and 1,314 ERCs for wastewater. LUSI is in the process of permitting the necessary expansions to its wastewater treatment plant. Total expanded plant capacity will be 3,570 ERCs. The plant expansions are anticipated to be complete by the end of 2007.

This Water and Wastewater Utility Agreement is for 629 ERCs for water and 629 ERCs for wastewater; however, only 163 connections are required before the plant expansions are complete. There is sufficient capacity in LUSI's existing water plant to provide water service pursuant to this Water and Wastewater Utility Agreement. There will be sufficient capacity in LUSI's wastewater plant to provide wastewater service to all phases of the development at the time such service is needed.

This Water and Wastewater Utility Agreement will have no noticeable impact on the Utility's rates due to the amount of demand being placed on the LUSI water and wastewater system, and resultant revenues.
