On October 4, 2005, the Commission voted unanimously to approve the revised SQM/SEEM plan originally approved in PAA Order No. PSC-05-0488-PAA-TP. Subsequently, it has been brought to BellSouth's attention that there is a typographical error in the SEEM portion of the plan. Specifically on page 33 of Appendix D., the parameter " r_{2j} " is shown as "the ILEC sample rate of cell j ; n_{2j} / b_{2j} ", but should read "the CLEC sample rate of cell j ; n_{2j} / b_{2j} ". That is, the word "ILEC" should be "CLEC." This typographical error does not affect the accuracy of SEEM calculations. To correct this typographical error, please find enclosed for filing a redlined and clean version of page 33 of Appendix D of the SEEM plan. A copy of the same is being provided to all parties of record.
