UNDOCKETED – Water Rate Design Commission Workshop

DATE AND TIME: Wednesday, February 1, 2006, 10:00 a.m.

PURPOSE: To give the Department of Environmental Protection, the Water Management Districts, and Commission staff an opportunity to present a comprehensive package of information to the Commissioners on the procedures used in designing water rates. The workshop will open with a discussion of the Department of Environmental Protection and the five Water Management Districts role in establishing water resource policy and how that policy interacts with the Florida Public Service Commission's (FPSC's) regulatory authority. That will be followed by a discussion of the procedures used to design water rates for FPSC jurisdictional utilities, including the type of data used in the analysis, the constraints considered in designing rates, and the rationale used to select a particular rate design for a given utility.
