
Dear Troy:

NOTICE TO CUSTOMERS

On October 13, 2005, Forest Utilities, Inc. filed an Application with the Florida Public Service Commission (FPSC) for approval of a bulk wastewater service rate so as to allow the Utility to provide service to a large mobile home park adjacent to its existing service territory. On December 27, 2005, Order No. PSC-05-1262-TRF-SU was issued by the FPSC approving the request of Forest Utilities, Inc. for establishment of the new bulk wastewater rate. That order has now become final and effective.

The new approved rate for bulk wastewater service is \$3.14 per thousand gallons of water used.

The new rate for bulk wastewater service approved by the FPSC has no impact on the rates charged for residential or general service customers of the Utility and affects only bulk service customers.
