**Withdrawal of Petition by the Florida Alliance of Information and Referral Services to Initiate Rule Making**

1. On June 21, 2005, the Florida Alliance of Information and Referral Services ("FLAIRS") filed a petition requesting the Public Service Commission to initiate rulemaking to amend s. 25-4.40 (3)(b), FAC, requiring that local exchange telecommunications companies include 2-1-1 instructions on the inside front cover of telephone directories for exchanges with 2-1-1 service.

2. On September 22, 2005, Commission staff conducted a rule-development workshop regarding the Petition. At the conclusion of the workshop, it was agreed by FLAIRS and by the representatives of local exchange telecommunications companies that they would work together to address issues relating to the Petition.

3. Following the rule development workshop, FLAIRS submitted a list of questions to the local exchange telecommunications companies requesting information that would assist 2-1-1 providers address Petition-related issues in their local areas. All companies responded in a timely and comprehensive manner.

4. FLAIRS and local exchange telecommunications companies have expressed an interest in continuing to pursue resolution of the issues raised by the Petition in a collaborative fashion.

**Wherefore**, FLAIRS respectfully withdraws its Petition from further consideration by the Commission.
