Dear Ms. Bayo:

This is a follow-up to my recent telephone conference with Patti Daniel regarding a showing of financial ability by Mr. Hosseini. There are several factors supporting his financial ability. First, he became the majority shareholder in April, 2004. Thus, he has had controlling interest in the Utility for almost two years, without any financial concerns on the part of the Utility. Second, the Utility is finishing up a rate case, and if we assume the Commission is doing its job, then the Utility will get compensable rates which will keep the Utility financially viable.

Lastly, the inter-company debt of the Utility is owed to two separate companies, both of which are controlled by Mr. Hosseini. Further, the companies controlled by Mr. Hosseini are building within the development, so he has a vested interest as a developer to make sure the Utility has the financial ability to expand as necessary.
