Kay,

We met today and established the new docket title. It should read:

"Joint application for approval of transfer ^{of} and control of ALLTEL Florida, Inc., holder of ILEC Certificate ~~No. 10~~ ^{None} and PATS Certificate No. 5942, from Alltel Corporation to Valor Communications Group, and for waiver of the ^{Ken} carrier selection requirements of Rule 25-4.118, F.A.C., due to the transfer of the long distance customers of ALLTEL Communications, Inc. to Alltel Corporate Holding Services, Inc."

The company codes of the entities involved are:

- TL716 - ALLTEL Florida, Inc.
- TG415 - ALLTEL Florida, Inc.
- TI498 - ALLTEL Communications, Inc.
- TK045 - Alltel Holding Corporate Services, Inc.

The docket is currently listed correctly in the above company codes except for the PATS. It should be removed from TG104 (ALLTEL Communications, Inc.) and placed in TG415.

Also, the name "ALLTEL" in the names for the first three companies above is in all caps in MCD, but not for the last one. It looks kind of funny in the title, but I guess that's the way it is supposed to be. The parent company, Alltel Corporation, isn't certificated, so I don't have an MCD reference for it. In the petition itself, none of the entities have "Alltel" in all caps.
