4. Trustee's objection to Claim No. 59, filed on May 9, 2001, in the amount of \$6,700.00, by Trent Boudreaux is granted in part and denied in part, the claim is allowed in the amount of \$4,650.00 as an unsecured priority claim and allowed in the amount of \$2,050.00 as a general unsecured claim;
5. Trustee's objection to Claim No. 123, filed on June 4, 2001, in the amount of \$3,110.00, by Mark Camerire is denied and the claim is allowed in full as an unsecured priority claim;
6. Trustee's objection to Claim No. 16, filed on April 27, 2001, in the amount of \$4,000.00, by Christopher A. Woodlee is denied and the claim is allowed in full as an unsecured priority claim;
7. Trustee's objection to Claim No. 102, filed on May 24, 2001, in the amount of \$330.00, by Scott O. Martin is denied and the claim is allowed in full as an unsecured priority claim;
