

**BELLSOUTH TELECOMMUNICATIONS, INC.'S UNOPPOSED MOTION FOR  
EXTENSION OF TIME TO FILE AN ANSWER TO COMPLAINT**

BellSouth Telecommunications, Inc. ("BellSouth") hereby files this Unopposed Motion for Extension of Time to File an Answer to the Complaint of National Telecom & Broadband Services, LLC ("National Telecom") for Breach of Interconnection Agreement and Petition for Emergency Order Restoring Service (hereinafter the "Complaint"), and says:

1. On January 26, 2006, National Telecom filed its Complaint against BellSouth. Consequently, BellSouth's Answer to the Complaint is due on February 14, 2006.
2. The parties are discussing the allegations contained in the Complaint.
3. BellSouth seeks a thirty (30) day extension of time, through and including March 16, 2006, in which to file an Answer to the Complaint. Such an extension will give the parties time to perform a more in-depth review of the disputed charges in the Complaint.
4. BellSouth makes this timely request in good faith and no party will be prejudiced by the Commission granting this Motion. National Telecom has no objection to the requested relief.

WHEREFORE, BellSouth respectfully requests a thirty (30) day extension of time, through and including March 16, 2006, to file an Answer to the Complaint.
