

EXTENSION OF TIME TO FILE DIRECT TESTIMONY**

(collectively "KMC") and Sprint-Florida, Incorporated ("Sprint-FL") and Sprint Communications Company Limited Partnership ("Sprint LP"), pursuant to Rule 28-106.204, Florida Administrative Code, hereby move the Florida Public Service Commission (hereinafter "Commission") to extend the time direct testimony is due by one week to February 27, 2006, and as grounds therefore, KMC, Sprint-FL and Sprint LP state:

1. Commission Order No. PSC-06-0054-PCO-TP issued January 23, 2006, set the due date for direct testimony as February 20, 2006.
2. KMC, Sprint-FL, and Sprint LP are involved in discussions looking to a possible resolution of various issues between the parties. Although there is no guarantee that this docket will be settled by the parties, the additional week will enable the parties to have a better understanding as to whether a resolution of some or all the issues is possible and allow the parties to better focus their resources.
3. Seven additional days on the direct testimony will not materially or adversely impact the remaining schedule for this case. All other dates will remain unchanged.






