RE: Closure of Docket 050837-TI; Request for waiver of carrier selection requirements of Rule 25-4.118 F.A.C., due to acquisition of telecommunications assets of American Long Lines, Inc., IXC Registration No. TJ753 by PaeTec Communications, Inc., IXC Registration No. TJ132; and request for removal from register of IXC Registration No. TJ753, effective December 31, 2005.

On October 19, 2005, staff received notification from American Long Lines, Inc. (AMLL) and PaeTec Communications, Inc. (PaeTec) of the merger of the two companies. According to the parties, AMLL would discontinue its operation in Florida and transfer all of its customers to PaeTec. On November 4, 2005, the parties requested a waiver of the carrier selection requirements of Rule 25-4.118, Florida Administrative Code. On November 17, 2005, a recommendation was filed to address the parties request for a waiver of the carrier selection requirements of Rule 25-4.118, Florida Administrative Code. AMLL's request to acknowledge cancellation of its IXC Registration was not included in the recommendation.

By Order PSC-05-1243-PAA-TI, issued December 21, 2005, the Commission granted the request for a waiver of the carrier selections requirements of Rule 25-4.118, Florida Administrative Code. The Commission further ordered that this docket be closed administratively upon receipt of the payment of American Long Lines, Inc.'s 2005 regulatory assessment fess. The order became final and effective upon issuance of Order PSC-06-0066-CO-TI, issued January 25, 2006.

AMLL, holder of IXC Registration No. TJ753, has paid the required regulatory assessment fees as required in Section 364.336, Florida Statutes, therefore; in accordance with Section 2.07.C.5.i, Administrative Procedures Manual, IXC Registration No. TJ753 can be removed from the IXC Registration list effective, effective **December 31, 2005**. In addition, since AMLL has paid the required regulatory assessment fees in accordance with the Commissions' Orders, this docket should be closed administratively.
