Staff requests permission to make an oral modification to its recommendation for Docket No. 060087-GU, which the Commission will address at the February 28, 2006, Agenda Conference. Staff would like to modify the recommendation statement and staff analysis in Issue 2, as shown below in legislative format:

Issue 2: Should this docket be closed?

Recommendation: Yes. If Issue 1 is approved, this tariff should become effective on February 28, 2006. If a protest is filed by a person whose substantial interests are affected within 21 days of the issuance of the Order, the tariff should remain in effect with any charges held subject to refund pending resolution of the protest. If no protest is filed, this docket should be closed upon the issuance of a Consummating Order. (Fleming)

Staff Analysis: If Issue 1 is approved, this tariff should become effective on February 28, 2006. If a protest is filed by a person whose substantial interests are affected within 21 days of the issuance of the Order, the tariff should remain in effect with any charges held subject to refund pending resolution of the protest.
